8. MANAGEMENT AND ADMINISTRATION

The Manager/Secretary acts as Chief Executive Officer and implements decisions of the Board. The Chairman presides over meetings and ensures proper governance.

9. GENERAL BODY

The General Body consists of all registered members and is responsible for electing the Managing Board, approving accounts, appointing auditors, and setting policies.

Membership includes founder members and approved individuals above 18 years. Members must follow the MOA and Rules and Regulations.

11. FINANCIAL MANAGEMENT

Funds are raised through donations, gifts, and grants and are used solely for the objectives of the Home. Accounts are audited and bank operations are handled jointly by authorized officers.

In case of dissolution, assets will be transferred to another society with similar objectives.
